Crime Exposed. Barrier models as an innovative tool against criminal phenomena

Tracking down perpetrators of criminal acts is often searching for a needle in a haystack for police forces. However, there is an innovative method that helps to approach criminal phenomena as efficiently as possible: the barrier model. This book shows how the police, together with public and private partners, can set up effective barriers to maximally disrupt the criminal's strategy. The authors do this using insights from situational prevention theory and a range of practical examples whose effects have been scientifically demonstrated (*evidence-based policing*).

The barrier model was put on point in the Netherlands, within the Centre for Crime Prevention and Safety (the CCV). Lienke Hutten, Dominique Rademaker and Joeri Vig describe the methodology used.

Afterwards, Tom Broekaert (DGJ) and an expert team from the federal police explain why the police are a valuable partner in the development, implementation, follow-up and evaluation of barrier models. They illustrate their argument with case studies on identity fraud and transit migration with "small boats".

Annemie De Boye (ARIEC Limburg) discusses how barrier models can be used to tackle human trafficking. In doing so, she draws on practical examples and *lessons learned* from the European project CONFINE. In turn, Ibrahim Bulut (ALLSECCON Security Consultancy) and Wesley De Smet (Museum voor Schone Kunsten Gent) apply the barrier model to art crime. Finally, Jelle Janssens (Ghent University) bridges the gap with recent scientific research on barrier models. He calls for a cautious and conscious application of this useful tool.

Not surprisingly, the barrier model was included in the Framework Memorandum on Integral Security and the National Security Plan 2022- 2025. This book is an important first step towards putting the model into general practice.
